50% of the total Exhibitor/Sponsor invoice is due upon receipt. The final 50% of the balance owing or cumulative 100% of the agreement is due by November 30, 2023. The full amount (100%) of the agreement is due upon receipt of the signed application when submitted November 30, 2023 onward.

# EXHIBITOR/SPONSOR AGREEMENT

Please read carefully as you and ALL representatives of your company will be held accountable for all items outlined in this agreement. The agreement to these terms must be signed on the Exhibitor/Sponsor Registration Form and initialed, returned with payment in order to reserve an exhibition or sponsorship slot.

**Binding Agreement:** We, the undersigned company, do hereby make application to participate as an Exhibitor/Sponsor (the "Exhibitor/Sponsor") at the 2024 The International Entrepreneur Summit, to be held at 789 Yonge Street Toronto, Ontario M4W 2G8 (Canada), April 15- 16, 2024. We understand and agree that this entire document constitutes as an Agreement (the "Agreement") between the Exhibitor/Sponsor and Diaspora Media Inc. Upon execution hereof both parties. This Agreement constitutes the entire agreement between parties and supersedes any previous understandings between parties. We, the undersigned company, have read and agree to comply with all Terms and Conditions contained in this Contract, including the "Exhibition Rules and Regulations", and any additional material provided by the 2024 The International Entrepreneur Summit, with respect thereto.

**Payment Policy:** All Exhibitor/Sponsors must make payments in accordance with the schedule outlined above. Exhibitor/Sponsors will not be permitted to exhibit if full payment of the contract has not been received in full. Any Exhibitor/Sponsor who does not pay by the scheduled due date will be responsible for all outstanding debts and interest at 2.0% per month, compounded monthly, and any fees or expenses, including, but not limited to, attorney's fees.

**Amendments:** Diaspora Media Inc. reserves the right to make or amend its Terms and Conditions and/or event dates.

**License:** This is a license Agreement, and the rights of the The International Entrepreneur Summit under this contract shall not be deemed waived except as specifically stated in writing by an authorized representative of Diaspora Media Inc.

**Successors:** This Agreement will be binding for the Exhibitor/Sponsor and the Diaspora Media Inc. successors and assignees.

**Severability:** If any term, clause or provision; hereof is held invalid or unenforceable by a court of competent jurisdiction, such invalidity shall not affect the validity or operation of any other term, clause or provision and the invalid term, clause or provision shall be deemed to be severed from the Agreement.

**Governing Law and Venue:** Any action arising out of this Agreement or the Exhibition must be brought in Toronto, ON and governed by the law of that locale, exclusive of the choice of law rules of any jurisdiction, and the Exhibitor/Sponsor consents to the jurisdiction of such courts.

**Termination:** In the unlikely event that the Exhibitor/Sponsor terminates this Agreement, fails or refuses to provide the deliverables as outlined in the sponsorship package or any part thereof in a timely manner, and such failure continues for a period of fifteen (15) business days after written notice from the Diaspora Media Inc. to Exhibitor/Sponsor, Diaspora Media Inc. shall terminate this agreement without further obligation to Exhibitor/Sponsor, and will consider the Exhibitor/ Sponsor to be in default of this Agreement.

Both parties agree that damages to The International Entrepreneur Summit and Diaspora Media Inc. would be difficult, if not impossible, to ascertain. It is agreed that a penalty for cancellation must insure against actual loss of gross revenue, the total expenses incurred less any recoverable, the necessary costs of remedial action incurred by Diaspora Media Inc. to replace the Exhibition/Sponsorship and/or the cost to minimize or avoid the extent of the loss. Therefore, in the event of default by Exhibitor/Sponsor, the Exhibitor/Sponsor will be responsible to pay no less than 100% of the total exhibitor or sponsorship fee as a cancellation/termination/default penalty. Penalty fee must be paid within 30 (thirty) days of the date of cancellation/termination/default. Any fee(s) already paid to, and received by Diaspora Media Inc. at the time of default shall be applied to such cancellation expenses.

In the unlikely event Diaspora Media Inc. fails or refuses to provide the services as outlined in this Agreement, or any part thereof, except by Force Majeure, and such failure continues for a period of fifteen (15) business days after written notice from Exhibitor/Sponsor to Diaspora Media Inc., Exhibitor/Sponsor may terminate this agreement without further obligation to The International Entrepreneur Summit. Any fee(s) paid to Diaspora Media Inc. at the time of such default, minus actual expenses incurred by The International Entrepreneur Summit toward that exhibitor/sponsorship shall be returned to Exhibitor/Sponsor within thirty (30) days.

**Force Majeure:** Diaspora Media Inc. may suspend or cancel obligations under this agreement with no penalty if such obligations are delayed, prevented or rendered impractical by any of the following events to the extent that the 2024 The International Entrepreneur Summit cancelled:

Fire, flood, riot, hurricane, earthquake, tornado, civil commotion, insurrections, acts of God, labor disputes or strikes at the event facility, war on Canadian soil, shortage of, or inability to obtain materials, supplies, utilities or equipment, and/or curtailment of transportation, which makes it inadvisable or impossible to execute the 2024 The International Entrepreneur Summit as planned and/or scheduled. In the event of any one or more of such reasons/situations, Diaspora Media Inc., its contractors, agents, employees and/or vendors will not be held responsible for the delay of, or failure to perform its obligations under this agreement. Further, exhibitor/sponsor is entitled to receive a refund of any advertising fee (s) already paid, minus any direct expenses incurred by Diaspora Media Inc. In the event that 2024 The International Entrepreneur Summit is rescheduled, all benefits as originally agreed shall be in effect, any/all exhibition/sponsorship fee(s) already paid shall be applied to the rescheduled event and any/all sponsorship fee(s) not yet paid would be due to Diaspora Media Inc.

**Indemnification:** Each party agrees to indemnify and hold harmless the other party and its employees, members, landlord, successors and assigns, from any claims, liabilities, losses, damages and expenses (including, without limitation, reasonable attorney's fees) asserted against the other party and arising out of the indemnifying party's negligence, willful misconduct and negligent performance of, or negligent failure to perform, any of its duties or obligations under this Agreement. The provisions of this indemnification are solely for the benefit of the parties hereto and not intended to create or grant any rights, contractual or otherwise, to any other person or entity.

**Non-Disclosure:** Diaspora Media Inc. agrees that it shall not, at any time, without the express written consent of Exhibitor/Sponsor, publish, disclose or divulge advertisers' information to any person, firm, or corporation or use advertiser's information, directly or indirectly, for its own benefit or the benefit of any such person, firm or corporation. Both parties agree that the intended use of any information, received by Diaspora Media Inc. from Exhibitor/Sponsor is for the sole purpose of marketing, publicizing, and executing advertising in/at the 2024 The International Entrepreneur Summit.

The obligations hereof shall terminate with respect to any particular portion of the Exhibitor/Sponsor's information when Diaspora Media Inc. can document that:

Sponsor's information was in the public domain at the time of The International Entrepreneur Summit communication thereof to any third party; or  
Exhibitor/Sponsor's information entered the public domain, through no fault Diaspora Media Inc., subsequent to the time of Exhibitor/Sponsor's communication there of Diaspora Media Inc.; or  
Exhibitor/Sponsor's information was necessary to the successful production, planning and execution of the 2024 The International Entrepreneur Summit. This might include, but not be limited to; names, addresses, meeting objectives, attendance numbers, etc., of employees and customers.
